Any applicant seeking to solicit within the city for a commercial purpose shall obtain an occupation tax registration and pay an occupation tax registration fee in the amount of (\$65) which is in the accordance with the City of Vidalia's fee structure or produce a valid occupation tax registration or certificate from another county or municipality of this state.

Any applicant seeking to peddle merchandise, article or good or other service shall obtain a regulatory registration and pay a regulatory registration fee of fifty dollars ( \$ 50.00 ).

I understand that any information obtained by personal history background investigation, which is developed directly or indirectly, in whole or part, upon this release is authorized in compiling any report for the City of Vidalia.
