#### 1. CALL TO ORDER BY MAYOR DOUG ROPER.

Mayor Doug Roper called this meeting to order at 8:10 a.m. The Invocation was given Councilmember Bob Dixon, who began the Pledge of Allegiance.

#### 2. DISCUSSION / APPROVAL OF AGENDA.

A motion was made by Councilmember Cecil Thompson to approve the agenda as written. A second was made by Councilmember Jennifer Evans. This motion passed unanimously.

#### POLICE & FIRE COMMITTEE MEETING - AUGUST 25, 2023

3. DISCUSSION / APPROVAL TO AWARD BID FOR PURCHASE OF (2) NEW PATROL VEHICLES AT A COST OF \$76,000.00. EQUIPMENT, TO INCLUDE INSTALLATION, AND GRAPHICS AT A COST OF \$5,010.00. TOTAL PURCHASE PRICE IS \$81,010.00.

Motion made by Councilmember Raymond Turner to adopt Resolution #23-012, establishing the 2023 millage rate for City of Vidalia, Montgomery County, at 3.933 mills. The second was made by Councilmember Bob Dixon. This motion passed unanimously.

11. DISCUSSION /APPROVAL OF COST ESTIMATE FOR SUPPLEMENT NO. 39
TO THE VIDALIA GA CODE OF ORDINANCES. THIS SUPPLEMENT IS FOR
UPDATES/ADDITIONS TO OUR CODE OF ORDINANCES SINCE SEPTEMBER
2020. APROVAL FOR AN ESTIMATE OF \$3,898.00, BUT NOT TO EXCEED
\$4,200.00. TO BE PAID FROM THE GENERAL FUND.

Motion made by Councilmember Loyd Mobley with a second by Councilmember Bob Dixon to approve cost estimate, not to exceed \$4,200.00. This motion passed unanimously.

12. DISCUSSION / APPROVAL TO EXECUTE AGREEMENT WITH K-DOUG FOR EMERGENCY SEWER REPAIRS PER O.C.G.A. §36-91-22, PUBLIC WORKS BIDDING, CONTRACTS AND REQUIREMENTS, EXCEPTION. THIS EMERGENCY REPAIR WAS DUE TO A COLLAPSED SEWAGE LINE DISRUPTING SERVICES OF THE CITY OF VIDALIA. THE COST OF REPAIRS IS \$59,512.97. THE FUND SOURCE FOR REPAIRS IS GEFA.

A motion was made to execute agreement with K-Doug for emergency repair of collapsed sewage line in the amount of \$59,512.97 to be paid from GEFA funds. This motion was made by Councilmember Loyd Mobley with a second made by Councilmember Bob Dixon. This motion passed unanimously.

## 13. EXECUTIVE SESSION WAS NEEDED PER §50-14-3, FOR THE PURPOSE OF PERSONNEL.

A motion was made by Councilmember Bob Dixon to enter into Executive Session for the purpose of Personnel. A second was made by Councilmember Loyd Mobley. This motion passed unanimously.

A motion was made to come out of Executive Session and return to regular session by Councilmember Loyd Mobley with a second made by Councilmember Cecil Thompson. This motion passed unanimously.

No further motions were made once returned to regular session, and with no further business, a motion was made to adjourn by Councilmember Bob Dixon with a second made by Councilmember Loyd Mobley. This motion passed unanimously and this meeting was adjourned at 9:00 a.m.
